ORDER

petition. Notice be issued to the respondents. PSPCL shall supply the following information:

- i) Whether PPA executed between the parties has been approved by the Commission ?
- ii) What is the total expenditure incurred by PSPCL?
- iii) Whether total expenditure incurred by the applicant has been passed on to the consumers?

The requisite information shall be submitted by PSPCL within two weeks. PSPCL shall also supply a copy of the I.A. to the respondents immediately. Respondents shall file reply to the I.A. by two weeks with a copy to PSPCL (through email and hard copy). PSPCL may file rejoinder, if any, to the reply within next two weeks with a copy to the respondents (through email and hard copy). NTPC must also appear. PSPCL shall ensure that the notice is served on NTPC.

The matter shall be taken up for hearing on admission of the I.A. on 18.04.2018 at 11.00 A.M.
