Nangal Unit, Naya Nangal District Roop Nagar Vs. Punjab State Power Corporation Ltd. through its Chairman.

With a further prayer to issue appropriate directions to respondents to forthwith comply with the order dated 03.11.2016 passed by this Hon'ble Commission in Petition No.36 of 2016.

With a further prayer to refund sum of Rs.4,50,08,690/- as ordered by this Commission along with interest to be as per the prevalent interest + 2% penalty thereon (as being claimed by respondent – Corporation on the delayed payment of bills) from 03.11.2016.

Any other order or direction which this Hon'ble Commission may deem fit in the facts and circumstances of the case including awarding costs of this petition and expenses incurred by engaging the counsel by filing of the present petition in favour of the petitioner and against the respondent – Corporation.
