PSPCL was further directed to ensure meticulous action as per Regulation 36.3.4 of the Supply Code 2014 and to conduct thorough internal check to identify such pending cases and to ensure strict compliance of the Regulations. Although PSPCL has refunded the 50% amount deposited by the petitioner to file Appeal before the Appellate Authority but despite repeated requests the amount of interest due to the petitioner has not been paid so far.
