Petition under Section 86(1) (f) of the Electricity Act, 2003 read with Rule 10, 69, 71 and 73 of the PSERC (Conduct of Business) Regulations, 2005 read with Section 94 of the Electricity Act, 2003, for seeking setting aside/ quashing of the order / letter dated 12.05.2021 issued by the respondent No. 1 / Punjab State Power Corporation Ltd. vide which the Power Purchase Agreement (PPA) dated 17.05.2019 executed between PSPCL and the petitioner for purchase of power from 1.5 MW biogas based Power project of the petitioner has been wrongly and illegally terminated.

With further prayer of Project specific extension of period of commissioning of the petitioner Company's biogas based 1.5 MW Power project upto 12.02.2024, as the delay in commissioning is occurring due to the reasons which were beyond the control of the petitioner, force majeure events and faults of the respondent No. 1/ PSPCL.

ORDER
