ORDER

The IA alongwith petition was taken up for hearing. The respondent No. 01 has neither appeared nor filed any reply. In the interest of justice, respondent No. 01 is granted the last opportunity to file its reply in the petition. The Ld. Counsel appearing for Respondent No. 02, 03 & 04 has submitted that no reply is required to be filed by the respondents.

PSPCL filed IA No. 29 of 2022 and submitted minutes of the meeting held on 30.09.2022, in support of the I.A. It was observed by the Commission vide order dated 25.01.2023 that IA cannot be considered merely on the basis of the minutes of a meeting and PSPCL may produce the Government specific policy decisions for issuing notification in this regard. PSPCL has submitted during hearing that the issues have already been taken with the Govt. of Punjab and a meeting in this regard was held on 21.03.2023 under the Chairmanship of Chief Secretary Govt. of Punjab and the notification/Minutes of Meeting are expected to be issued soon. It was further submitted by PSPCL that the relevant Regulations of the Supply Code are also required to be amended and proposal in this regard has been taken up as agenda in the next meeting of Supply Code Review Panel. PSPCL requested for some more time to submit the necessary submissions in

compliance of the order dated 25.01.2023. PSPCL is granted a final opportunity to file the same within 4 weeks.

The petition alongwith the IA shall be taken up for hearing on 21.06.2023 at 11.30 AM.
