ORDER

The Petition was taken up for hearing. Vide Order dated 16.05.2023, PSPCL was directed to submit activity wise timelines for completion of work for releasing the electricity connection. PSPCL submitted the same vide memo no. 6552 dated 19.07.2023. The Northern Railways has submitted its reply to the activity timelines vide memo dated 08.09.2023. The Learned Counsel for Railways submitted that there is delay on the part of PSPCL in issuing the feasibility clearance, transfer of funds to PSTCL for

carrying out the works and in filing of the petition. Moreover, despite reduction in the scope of work, an unexplained extension of timelines has been sought by PSPCL from 31.12.2024 to 31.08.2025 whereas work of RTSS is expected to be completed by February, 2024. PSPCL has not made any rigorous efforts for expeditious release of the connection. A bare perusal of the activity wise timelines submitted by PSPCL shows that only broad timelines have been summarily submitted without their detailed breakup and without taking into account the urgency of the matter. It was directed that PSPCL shall submit detailed activity-wise timelines for completion of work for releasing the electricity connection keeping in view the objections/suggestions made by Northern Railway within two weeks.

The Petition shall be taken up for hearing on 25.10.2023 at 11:30 A.M.
