## ORDER

The petition was taken up for hearing. NPL has filed an IA seeking Interim relief to determine provisional tariff till the supplementary tariff is determined and to direct PSPCL to participate in the bidding process for supply of limestone. The Ld. Counsel for PSPCL requested for time to file reply to the petition as well as the IA and further submitted that as the matter is under litigation before the Hon'ble Supreme Court in Appeal No. 6688 of 2020 and 3763 of 2020, the proceedings in the present petition may be postponed. The Ld. Counsel for NPL submitted that pendency of the matter before the Hon'ble Supreme Court does not stand as a bar in the hearing of the present petition. Whereas, TSPL is seeking exemption from the proceedings and directions passed by the Commission in this petition with liberty to approach the Commission for approval of actually incurred additional capital cost post implementation and commissioning of the required system to comply with aforesaid MoEF & CC notification. PSPCL may file its reply in the petition alongwith IA within two weeks with a copy to the other parties (through hard copy & soft copy)
