## **ORDER**

The petition was admitted vide order dated 07.12.2023 and PSPCL was directed to provide further information vide order dated 07.12.2023, order dated 03.01.2024 and order dated 31.01.2024. However, since the information received is incomplete, PSPCL is further directed to provide information as under:

- PSPCL to provide details of scheme wise capitalization for 2nd MYT control period.
- 2. Detail of interest on long term loan taken from financing Shahpur Kandi Project whose capex was not allowed by the Commission. The details be sent on the format annexed with this order (Annexure-A)

3. In letter dated 22.12.2023 pertaining to its response on the deficiencies under Item 10(i) Status of RPO Compliance for FY 2022-23, PSPCL, while praying for consideration of its request to allow the compliance of RPOs in terms of MoP Notification dated 22th July 2022, has submitted the details of its compliance only on a consolidated bases. For consideration of the same, it needs to be submitted, source wise i.e. HPO, wind RPO, other RPO and total RPO, as mandated under the said notification.

4. Under item 11(ii) Tariff for Green Energy, it was stated to be under consideration and that it would be submitted subsequently. However, the same is still awaited. PSPCL to submit the proposal without any further delay.

PSPCL shall submit reply to the above information within three days without any delay (through hard copy & soft copy).
