ORDER

PSPCL filed Petition No. 66 of 2022 for extension in time for release of EHT connection of 4500 KW load/ 5000 kVA contract demand applied by Senior Divisional Electrical Engineer (TRD) DRM Office Ferozpur under the category, Railway Traction which was disposed of by the Commission vide order dated 01.06.2023. PSPCL was directed to release the electricity connection by 31.07.2024 by making all out efforts. PSPCL has filed the present petition submitting that due to pending PTC approval and Forest Department clearance, the sagging work of 2 spans could not be completed till 31.07.2024 and has prayed for extension of time in releasing the connection upto 30.11.2024.

The petition has been placed before the Commission for admission. Petition No. 66 of 2021 has already been decided vide order dated 01.06.2023 and as the relief sought in the present petition is only for extension of time in releasing the connection, the same is taken on record as an IA in Petition No. 66 of 2022. Notice be issued to Sr. Divisional Electrical Engineer (TRD), DRM office Ferozpur. Northern Railway may file reply to the IA, if any, within two weeks with a copy to the petitioner (through hard copy & soft copy). PSPCL may file rejoinder to the reply filed by the respondent within

one week thereafter with a copy to the respondent (through hard copy & soft copy).

The IA shall be taken up for hearing on 25.09.2024 at 11.30 AM.
