- (III). The Supply Code Review Panel shall come into being on the date of publication in the Punjab Government gazette and have a term for a period of two years.
- (IV). A non-official member of the Review Panel will be entitled to receive for each day on which the meeting is held and he is present, travelling allowance at the rate admissible to Grade-I officer of the State Government and sitting fee of Rs.1000/- (Rs. One Thousand only).
