<u>ORDER</u>

Punjab State Transmission Corporation Limited, State Load Dispatch has Centre (PSTCL/SLDC) filed this petition in the matter of non-implementation of Automatic Demand Management Scheme (ADMS) resulting in violation of Regulation 5.4.2 (d) of Central Electricity Regulatory Commission (Indian Electricity Grid Code) Regulations, 2010. The petitioner has prayed for issuing directions to Punjab State Power Corporation Limited (PSPCL) to implement Automatic Demand Disconnection schemes in its control area for maintaining voltage and frequency profile and send the period i.e. progress reports as per provisions of the Indian Electricity Grid Code; to take responsibility of show cause notice issued to SLDC; to give clarification for delay in implementation to CERC and to provide time bound action plan regarding implementation of ADMS.

The petition was taken up for admission on 24.06.2014. After hearing the petitioner, the Commission observed that the matter is required to be taken up immediately in the State Grid Code Review Committee for implementation of various provisions of State Grid Code regarding Demand Management. Thereafter, the petitioner was directed to submit the 'action taken report' on the issue by the State Grid Code Review Committee.

PSTCL failed to file any 'action taken report' of the State Grid Review Committee on the issues raised in compliance with Order dated 30.06.2014. PSTCL / SLDC was again directed vide Order dated 16.07.2014 to file the same by 05.08.2014.

Chief Engineer/SLDC submitted vide memo No.243/T-294 dated 05.08.2014 that as per Order dated 16.07.2014, a meeting of the State Grid Code Review Committee (SGCRC) was held on 01.08.2014 in view of requirement of clause 5.4.2 (d) of the Indian Electricity Grid Code (IEGC) for implementation of Automatic Demand Management System and minutes of the meeting were under finalization. PSTCL sought further time of one week to file the reply / minutes of meeting of State Grid Code Review Committee.

Chief Engineer/SLDC has filed reply alongwith the minutes of meeting of the SGCRC vide No.1165/T-294 dated 06.08.2014.

After hearing PSTCL and PSPCL and considering the minutes of meeting of SGCRC, the Commission observes that PSTCL and PSPCL should be able to file the necessary information before the Hon'ble Central Electricity Regulatory Commission in compliance with directions vide Record of Proceedings in Petition No.5/SM/2014 and Petition No.10/RP/2014. Accordingly the Commission decides not to admit this petition for further proceedings.

The petition is disposed of accordingly.
