In the matter of : Petition under clause 47, 48, 49 and 50 of the Punjab State Electricity Regulatory Commission (Electricity Supply Code and Related Matters) Regulations, 2007 and other relevant sections of the Electricity Act, 2003 read with clause 9 of the Punjab State Electricity Regulatory Commission (Conduct of Business) Regulations, 2005, seeking clarification / modification / interpretation of the proviso of clause 9.1.2 (i) (c) of the Punjab State Electricity Regulatory Commission (Electricity Supply Code and Related Matters), Regulations, 2007;

And further for setting aside the demand raised and charged by the respondent on account of Service Connection Charges for additional load taken by the petitioner, as the petitioner has already paid actual cost of the independent feeder through which the petitioner is getting electricity and the additional load can be fed from the same line / feeder without any augmentation.

Any other order or direction which the Commission may deem fit and proper may also be passed in favour of the petitioner, in the interest of justice.

The petition is not maintainable before this Commission against the decision of ZLDSC of the Licensee for which the complainant / consumer shall have to follow the PSERC (Forum and Ombudsman) Regulations, 2005.

The petition is dismissed.
