**ORDER**

The petition was taken up for hearing. PSPCL has filed its submissions on the reply filed by Northern Railway to the rejoinder filed by PSPCL. The Ld. Counsel appearing for PSPCL submitted that Northern Railway has not handed over the land to PSPCL/PSTCL on which the 220 KV switching station at Bahawal Bassi is to be constructed. Northern Railway was requested in this regard to handover the land to PSPCL/PSTCL vide letter dated 13.11.2024 and 02.12.2024. However, the Ld. Counsel appearing for Northern Railway submitted that the land is not an issue as the land belongs to Railway administration and they had already given their consent to provide requisite land to PSTCL without any lease rent. But the Ld. Counsel appearing for PSPCL contended that the possession of the land is yet to be given by the Northern Railways. As the issue of transfer of land is disputed between the parties, PSPCL shall convene a joint meeting with Northern Railway within a week to resolve the issue and submit the report well before the next date of hearing. Further, the Northern Railways sought two weeks'

time to file rejoinder to the reply filed by PSPCL. The Northern Railways is allowed two weeks to file rejoinder with a copy to PSPCL (hard & soft copy).
