Petition under Section 142 and 146 of the Electricity Act, 2003 for taking necessary action against the respondents for violating the provisions of Regulation 6.3, 9.1.3 and 9.2 of the Punjab State Electricity Regulation Commission (Electricity Supply Code and Related Matters) Regulations, 2014 (hereinafter to be called Supply Code-2014) and further for seeking directions to the PSPCL to comply with the clause 9.1.3 and 9.2 of the supply code-2014 and release the extended load of the petitioner through idle circuit of Double Circuit 66 kV line already existing near the factory of the petitioner, and further in case the load cannot be released from this line then to recover charges as per clause 9.1.3 (iii) of the Supply Code-2014 only, in the interest of justice.
