**INVITATION OF APPLICATIONS FOR NOMINATION
AS A MEMBER TO THE FORUM**

Vacancy circular

The Punjab State Electricity Regulatory Commission, invites applications from interested eligible persons for nomination as an independent Member to the Forum constituted under sub-section (5) of Section 42 of the Act, for redressal of grievances of the consumers.

2. The nominated Member shall carry out the functions/duties entrusted to the Forum as envisaged under sub-section (5) of Section 42 of the Electricity Act, 2003 read with “PSERC (Forum and Ombudsman) Regulations, 2005.” as amended upto date.

3. In order to be eligible for consideration of nomination as a Member to the Forum, the applicant should be atleast 45 years of age and a Post-graduate. Preference would be given to the person who has association with a NGO, has knowledge of power sector and familiarity with consumer affairs and arbitration matters.

4. The candidate shall not have been in employment in any capacity under/or agency of the Distribution Licensee.

5. Initially, the nomination shall be for a period of two years. The nominated Member will hold office for a maximum period of three years, subject to overall age limit of 65 years.

6. He will be paid a consolidated amount of Rs. 30,000/- (Rupees thirty thousand only) per month towards remuneration. In addition, he will be entitled to all office facilities and TA/DA as admissible to Grade-I officers of the State Govt.

7. His headquarters shall be at Patiala or at the station where the office of the Forum (s) is located.

8. In respect of any matter not specifically mentioned above, the nomination will be governed by the terms & conditions as specified in the “PSERC (Forum and Ombudsman) Regulations 2005” as amended upto date.

9. The interested persons may send their applications with the following bio-data to the Secretary, Punjab State Electricity Regulatory Commission, SCO No.220-221, Sector 34-A, Chandigarh, latest by 19.05.2014.

- b) Age & Date of Birth
- c) Present assignment, if any
- d) Educational Qualification
- e) Whether the candidate possesses working knowledge of Punjab.
- f) Details of posts previously held and experience.
- g) Experience/knowledge of power sector in Punjab and/or other States/Centre.
- h) Familiarity with the consumer affairs and arbitration matters.
- i) Details of association with non-governmental organization
- j) Any other relevant information

In case the interested person is already in service, he should furnish an undertaking from his employer to the effect that he will be relieved from service in the event of his being selected for nomination.

10. The envelop containing application may be superscribed as "Application for nomination as a Member to the Forum".

11. The decision of the Commission in all matters would be final and binding and no correspondence in this regard shall be entertained.
