Petition under Regulations 3.5 and 47 read with 44,45,46 of PSERC (Electricity Supply Code and Related Matters), Regulations, 2014 read with Regulation 69 of the Punjab State Electricity Regulatory Commission (Conduct of Business) Regulations 2005, for seeking amendment/interpretation/clarification regarding Clause 4.3 of the Supply Code, 2014 to the effect whether the consumers can have connection for Cluster Sub Stations from existing 66 kV Supply Lines instead of from independent line from Feeding Sub Station and further to the effect that the consumers getting connections for Cluster Sub Station from existing 66 kV supply lines are liable to pay proportionate Cost of 66 kV line.

ORDER

The petitioners have filed the present petition seeking amendment/clarification of Regulation 4.3 of the Supply Code, 2014 to the effect that the connections can be issued to the Cluster Sub-Stations by tapping the existing 66kV

Supply Lines and for specifying the proportionate cost of 66 kV supply line to be recovered from the consumer.

The petition was taken up for hearing on admission. Regulation 3 of the Supply Code, 2014 pertains to Review Panel and amendment in Supply Code. As per Regulation 3.2 of the Supply Code one of the functions of the Review Panel is to recommend amendments in the Supply Code, wherever required. PSPCL has filed its reply to the petition and has further submitted vide memo No. 5252 dated 01.02.2022, that the proposed amendment has been included in the proposals for consideration by the Supply Code Review Panel its next meeting. Accordingly, the prayer made in the present petition shall be considered by the Review Panel as per the procedure applicable in this regard.

The petition is disposed of accordingly at the admission stage.
