- (II) The Supply Code Review Panel will meet at least once in six months and perform the functions in the manner as specified in Regulation 3.2 of the PSERC (Electricity Supply Code and Related Matters) Regulation, 2014.
- (III) The Supply Code Review Panel shall come into being on the date of publication in the Punjab Government Gazette and shall have a term for a period of two years.
- (IV) A non-official member of the Supply Code Review Panel will be entitled to receive for each day on which the meeting is held and he/she is present, the travelling allowance at the rate admissible to Grade-I officer of the State Government and sitting fee of Rs. 1000/- (Rs. one thousand only).
