NOTIFICATION

No. PSERC/Secy./Regu.142.- In exercise of powers conferred under Section 181 (zg) and (zp) read with the provisions of Section 86 (g) of the Electricity Act, 2003 and all other powers enabling it in this behalf, the Punjab State Electricity Regulatory Commission hereby makes the following Regulations to amend the Punjab State Electricity Regulatory Commission (Fee) Regulations, 2005 including 1st and 2nd amendments thereof (hereinafter referred to as 'the Principal Regulations') namely:

1. Short title and Commencement

- (i) These regulations shall be called Punjab State Electricity Regulatory Commission (Fee) Regulations (Third Amendment), 2019.
- (ii) These Regulations shall come into force from the date of their publication in official gazette of the State.

2. Amendment in Regulation 3 (2) of the Principal Regulations

The Regulation 3(2) of the Principal Regulations shall be substituted as under:-

The fees payable under these Regulations shall be paid into the Fund of the Commission by means of a bank draft or pay order drawn on any Scheduled Bank payable at Chandigarh or through IMPS, RTGS, NEFT in favour of Punjab State Electricity Regulatory Commission provided however, that amounts less than Rs.500/- (Rupees five hundred only) can be made to the Commission in cash for which duly numbered and signed receipts shall be issued to the depositor.

3. Amendment to Schedule of Fee- Part-C (Miscellaneous) of the Principal Regulations

- (i) The Sr. No. 4 under Part-C of the Schedule of Fee of the Principal Regulations shall be substituted

as under:-

(iii) The Sr. No.7 under Part-C of the Schedule of Fee of the Principal Regulations shall be substituted as under:-

(iv) The Sr. No.8 under Part-C of the Schedule of Fee of the Principal Regulations shall be substituted as under:-
