No. PSERC/Secy./Regu.184.—In exercise of the powers conferred under sub-section (2) (zk) of Section 181 read with sub-section (2) and (3) of Section 91 of the Electricity Act, 2003 (36 of 2003) and all other powers enabling it in this behalf, the Punjab State Electricity Regulatory Commission, with the approval of the State Government, hereby makes the following Regulations namely:-

1. Short Title and Commencement:

- (a) These Regulations may be called the “Punjab State Electricity Regulatory Commission (Appointment & Service Conditions of Employees) (Second Amendment) Regulations, 2023”.
- (b) These Regulations shall come into force from the date of their notification in the official gazette of the Government of Punjab.
