PUNJAB STATE ELECTRICITY REGULATORY COMMISSION

NOTIFICATION

The 11th June, 2024

No. PSERC/Secy/Regu.189.-In exercise of the powers conferred under sub-section (2) (zk) of Section 181 read with sub-section (2) and (3) of Section 91 of the Electricity Act, 2003 (36 of 2003) and all other powers enabling it in this behalf, the Punjab State Electricity Regulatory Commission, with the approval of the State Government, hereby makes the following Regulations namely:-

1. Short Title and Commencement:

- (a) These Regulations may be called the “Punjab State Electricity Regulatory Commission (Appointment & Service Conditions of Employees) (Third Amendment) Regulations, 2024”.
- (b) These Regulations shall come into force from the date of notification in the official gazette of the Government of Punjab.

2. The following shall be substituted to the 'Note' under Annexure-'B' of Regulation 8 (b) of Punjab State Electricity Regulatory Commission (Appointment & Service Conditions of Employees) Regulations, 2015:-

Note: Lumpsum payment of contractual employees is not to be less than the rates as approved by DC, Chandigarh at any point of time.

3. The Regulation 6(f) of Punjab State Electricity Regulatory Commission (Appointment & Service Conditions of Employees) (First Amendment) Regulations, 2023 is deleted.
4. The following shall be amended under Regulation 5(a) Qualifications and experience for appointment of “Punjab State Electricity Regulatory Commission (Appointment & Service Conditions of Employees) Regulations, 2015”, **Annexure-C** as under:-
