The order dated 19.03.2024 of CCGRF, Ludhiana in Case No. CF-022/2024 was required to be implemented by the Sr. XEN/DS Division, PSPCL, Bhogpur (Respondent) within 21 days of receipt of this order as per Regulation 2.33 of PSERC (Forum and Ombudsman) (2nd

Amendment) Regulations, 2021. The consumer had filed an application under Regulation 2.33 in this Court on 26.04.2024 that the decision had not been implemented fully by the Respondent till date and proceedings be initiated against the Respondent. The application was sent to the Respondent with a request to intimate the current status of implementation of decision dated 19.03.2024 of CCGRF, Ludhiana under intimation to the Applicant vide letter nos. 239-40/OEP/CO-04/2024 dated 26.04.2024. Thereafter, a hearing was fixed in this Court for 09.05.2024 and intimation to this effect was sent to both the parties vide letter nos. 250-51/OEP/CO-04/2024 dated 02.05.2024.

Today, during hearing, the Applicant's Representative (AR) submitted that the interest on proportionate cost of back up line deposited by the consumer was not given by the Respondent. Secondly, as GST amount of ₹ 4,51,917/- was deposited on 01.05.2024, so the interest on this amount should also be given upto 01.05.2024. He further requested that the interest only upto 31.03.2024 has been given, it should be given upto the date of credit to the Applicant's account. Also, the detail of expenditure on civil works for 66 kV bay amounting to ₹ 4,31,306/- has not been provided. The Respondent assured that he will resolve all these issues of the Applicant within 15 days & requested this Court to allow him time. As such, time is granted. The Respondent is directed to fully

implement the said decision of the CCGRF within 15 days & intimate this Court as well as the Applicant.

The next date of hearing is fixed for 24.05.2024 at 12.00 PM. Both the parties are directed to be present on the next date of hearing.
