08.07.2024, 393-94/OEP/CO-05/2024 dated 17.07.2024, 413-14/

OEP/CO-05/2024 dated 24.07.2024, 439-40/OEP/CO-05/2024 dated 07.08.2024 & 458-59/OEP/CO-05/2024 dated 21.08.2024 respectively.

Today, the Respondent submitted Memo No. 4760 dated 03.09.2024, a copy of which was provided to the Appellant. The Respondent requested this Court to make the office of EIC/Commercial, PSPCL, Patiala the respondent in this case so that the justice may be delivered to the Applicant as directed by the Corporate Forum, Ludhiana in its decision dated 28.03.2024.

This Court observed that the Corporate Consumer Grievances Redressal Forum (Corporate Forum), Ludhiana in Case No. CF-045/2024 had passed the following orders on 28.03.2024:-

“The decision dated 09.11.2023 of Divisional CGRF, DS Division, Patran is set aside. EIC/Commercial, PSPCL, Patiala is directed to expedite the action in this matter and put up the case to the competent authority for policy decision as per the decision of B.O.Ds dated 26.05.2022, within 2 months in order to facilitate release of AP connection of the petitioner without any further delay.”

EIC/ Commercial, PSPCL, Patiala is directed to submit the action taken as per the above decision of the Corporate Forum, Ludhiana with this Court before next date of hearing.

The next date of hearing is fixed for 12.09.2024 at 12.00 PM. Both the parties are directed to be present on the next date of hearing.

EIC/ Commercial, PSPCL, Patiala or his authorised representative should also attend this Court on said date and time.
