PUBLIC NOTICE

Inviting Objections/Comments in respect of Draft Punjab State Electricity Regulatory Commission (Terms and Conditions for determination of Generation, Transmission Wheeling and Retail Supply Tariff) Regulations, 2022

In exercise of the powers conferred under section 181 (2) read with Section 61 and 62 of the Electricity Act 2003 (36 of 2003) and all the other powers enabling the Commission in this behalf the Punjab State Electricity Regulatory Commission notified the Punjab State Electricity Regulatory Commission (Terms and Conditions for Determination of Generation, Transmission, Wheeling and Retail Supply Tariff) Regulations, 2019 vide notification dated 29.05.2019 which were made applicable for the 2nd MYT Control Period from FY 2020-21 to 2022-23. The Regulations were subsequently amended vide notification dated 16.03.2022.

Now with the 2nd MYT Control period coming to an end on 31.03.2023, draft MYT Regulations for Generation (Thermal & Hydel), Transmission, SLDC and Distribution (wheeling and retail) functions, to be made applicable for the next (3rd) control period of 3 years i.e. FY 2023-24 to FY 2025-26 has been prepared by staff of the Commission, which is available on the website of the Commission www.pserc.gov.in.

Objections/Comments, if any, on the draft Regulations may be filed with the Secretary, Punjab State Electricity Regulatory Commission, Site No. 3, Madhya Marg, Sector-18A, Chandigarh, **within 21 days** of the publication of this notice. The objections should be filed in one hard copy and should carry signature, full name, postal address and telephone/mobile number of the

person filing the objection. All the objectors may also send a soft copy of their objections to the Secretary/P SERC at email id "secretarypsercchd@gmail.com". **The Commission will hold a Public Hearing in this connection on 24.08.2022 at 11:00 A.M.** in the Commission's office i.e. Site No.3, Madhya Marg, Sector-18A, Chandigarh. Persons/organizations interested in presenting their views in the matter before the Commission are invited to participate. If any member of the public wants to Attend the hearing virtually then they may send their full name, contact no. and valid email id to secretarypsercchd@gmail.com and the link for the same will be provided by the Commission
