If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned. It may also be specifically mentioned if the person putting in objections/comments also wants to be heard in person.
5. The Punjab State Electricity Regulatory Commission shall hold a public hearing in the matter on **15.10.2019 at 11.00 AM** in the Commission's office. All the objectors who have filed their objections with the Commission by the last date for filing of the Comments/Objections and other persons/organizations interested in presenting their view/suggestions on the above mentioned matters before the Commission are invited to participate.
