**PUBLIC NOTICE INVITING OBJECTIONS  
IN RESPECT OF PETITION NO. 9 OF 2013  
FILED BY THE PUNJAB STATE POWER CORPORATION LIMITED  
FOR AUTHORISING IT TO IMPOSE POWER CUTS,  
PEAK LOAD HOURS RESTRICTIONS AND TAKING OTHER  
POWER REGULATORY MEASURES DURING  
THE YEAR 2013-14.**

1. Notice is hereby given to all that the Punjab State Power Corporation Limited (PSPCL) has filed petition before the Commission for authorizing the PSPCL to impose power cuts, peak load hours restrictions and taking other power regulatory measures during the year 2013-14.
2. Copies of the petition are available in the offices of the Chief Engineer/ARR & TR, PSPCL, Patiala, Liaison Officer, PSPCL Guest House, Opposite Yadvindra Public School, Phase-8, S.A.S. Nagar(Mohali), all Chief Engineers (Distribution) and all SEs incharge of Distribution Circles of the PSPCL. The petition is also available on the website of the Commission at the address 'www.pserc.nic.in' and can be downloaded therefrom.
3. Interested persons may inspect and peruse the petition and take notes thereof during office hours at any of the above said offices free of charge.
4. Copy of the petition can be obtained from any of the above offices on payment of Rs.20/-.
5. Objections against the petition filed by the PSPCL for authorizing it to impose power cuts, peak load hour restrictions and taking other power regulatory measures together with supporting material, may be filed with the Secretary, Punjab State Electricity Regulatory Commission at the address mentioned above in person or through Registered Post so as to reach him upto 21.3.2013. Copy of the same must also be sent to Chief Engineer/ARR & TR, PSPCL, Patiala and proof of service of the same must be enclosed with the filing made to Secretary, Punjab State Electricity Regulatory Commission.
6. The objections to the Commission should be filed in seven copies and carry full name and postal address of the person sending the objection. If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned. It may also be specifically mentioned if the objector also wants to be heard in person.
7. Public hearing in this respect will be held on 28.3.2013 at 11.30 A.M. at Commission Office i.e. SCO 220-221, Sector 34-A, Chandigarh.
