Sealed Tenders are invited upto 27th September 2022 (01:00PM) for supply of material, installation and commissioning of Audio Video System for the Court Proceedings via Video Conferencing for this office. The specification of the material required is as under:

Tenders will be opened on the same day i.e. on 27th September 2022 at 03:00 PM. The bidders or their representatives can remain present at the time of opening of Tenders.

Terms and Conditions:

1. The Tender documents received beyond the said date and time shall not be accepted.
2. Firms should clearly quote their rates, both in figures and in words. Any overwriting in rates or any change is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.

3. GST should be mentioned separately.
4. Tenders will be valid for a period of 30 (thirty) days from the date of opening of the tenders.
5. The Commission has the right to accept or reject any Tender without assigning any reason.
6. Each firm shall submit only one Tender, either by himself or as a partner in a joint venture. A firm which submits or participates in more than one Tender, will be disqualified.
7. Conditional Tender shall not be accepted.
8. The firm will give the undertaking that they are not blacklisted by any Government Organization.
9. The material should have at least 1 year warranty.
10. The cost of Annual Maintenance Contract (AMC) for two years should be mentioned separately.
11. The firm shall be required to submit earnest money (EMD) @ 2% of tendered value in form of bank draft in favour of "The Punjab State Electricity Regulatory Commission Fund" along with the Tender. The Tenders/ Quotations not accompanied by the requisite amount of earnest money will be rejected.
12. After successful testing and commissioning of the Audio Video System, 90% payment of the contract value will be paid along with taxes and duties within 30 days against receipted challans and submission of requisite documents. The balance 10% payment shall be kept as performance guarantee which will be released on expiry of three months from the date of receipted challans and submission of requisite documents.
